With reference to your application dated 21-02-2022 and subsequent correspondence with the school. I convey the grant for Provision recognition to The Chairman, Guru Nanak Public School, Dalhousie Tehsil Dalhousie , District Chamba (H.P.)176304 (Name of the School with address) for Class 1st (First) to Class 8th (Eighth) for a **Recognition period of April,2022 to March,2027 Year** .
The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure-I) and Right of Children to Free and Compulsory Education Rules, 2011 (Annexure-II).
3. The Society /School shall not collect any capitation fee and subject the child his or her parents or guardians to any screening procedure.
4. The School shall not deny admission to any child.
 - (I) for lack of age proof.
 - (II) If such admission is sought subsequent to the extended period of ninety days for admission; and
 - (III) on the ground of religion, caste or race, place of birth or any of them.
5. The School shall ensure that;
 - (I) No child admitted shall be held back any class or expelled from school till the completion of elementary education in that school.
 - (II) No child shall be subjected to physical punishment or mental harassment;
 - (III) No child is required to pass any board examination till the completion of elementary education;
 - (IV) Every child completing elementary is awarded a certificate as laid down under rule 19 of the Right of children to free and compulsory Education, Himachal Pradesh Rules, 2011.
 - (V) Student with disabilities /special need is given admission as per provision of the Act.
 - (VI) The teachers are recruited with minimum qualification as laid down under section 23(1) of the Act the current.
 - (VII) The teacher perform his/ her duties specified under section 24(1) of the Act and.
 - (VIII) The teacher shall not engage himself for private teaching activities.
6. The school shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section 19 of the Act,
7. The School shall enroll students proportionate to the facilities available in the school specified in the Section (1) of Section 29.
8. The School maintains the standard and norms as specified in section 19 of the Act. The facilities reported at the time of last inspection are as under:-
